## KEY RESULTS FOR 2020

 **Nearly 2.7 million vulnerable Lebanese, Syrians and Palestine refugees were reached** through LCRP interventions across Lebanon in 2020.

 **Funds covering 63% of the 2020 appeal** of US \$2.67 billion were made available, representing the **highest coverage since 2017**. However, funding shortages, imbalances and gaps in multi-year funding remain key obstacles for many sectors, such as Livelihoods, Shelter and Basic Assistance.

 **Over US \$429 million was injected into Lebanon's economy through cash-based interventions** supporting vulnerable families. This is a quarter of the LCRP's total available funding.

 **More people were reached with food assistance in 2020 than any other year**, with over 1.46 million people reached. Four times more vulnerable Lebanese were reached than in 2019 by increasing the number of people included in existing programmes. Support through the National Poverty Targeting Programme was scaled up to reach more than 105,000 individuals and distributing \$23 million in cash food assistance.

 **Nearly 3,300 small-scale Lebanese farmers were supported** through strengthened technical and operational capacities or inputs distribution to sustain and protect their farming activities and mitigate the risks to agricultural production, productivity and sustainability driven by Lebanon's multiple crises. **The total value of investments in agricultural worksites reached US \$806,396 and 13 value chains were valorized and upgraded.**

 **Over 51,000 people were employed through cash for work, benefiting over 255,000 people.** For every 1 person employed through cash for work activities, over 5 people benefit from the income provided so they can meet their basic needs and avoid negative coping mechanisms.

## TOTAL POPULATION REACHED IN 2020



**With rising needs across populations, access to services was scaled up across sectors:**



Nearly 1.4 million subsidized health consultations were provided to **700,000 vulnerable refugees and Lebanese**. Nearly 84,000 refugees also received financial support for hospital care.



Nearly 40,000 people received subsidized mental health services with **15% more people accessing mental health services** compared to 2019.



With the support of Water Sector partners, **over 1.4 million people now have improved access to safe water in permanent locations**. **Scale-up of water trucking** for COVID-19 prevention benefited some 351,000 people. Over 272,000 people in informal settlements were reached through **improved sanitation services**.



**432,500 non-Lebanese and vulnerable Lebanese children were enrolled in public schools** in the 2019-2020 school year (nearly 100% of the target). **Nearly 50% of refugee children** in Lebanon were enrolled in public or private schools in the 2019-2020 school year.



**Over 1.41 million tailored protection services were provided** to persons in need, including **126,297 vulnerable Lebanese**. Approximately **US \$5.67 million was provided to over 32,000 persons with specific needs** to address urgent protection risks and other emergencies.



Children at high risk of violence, exploitation, neglect and abuse are in urgent need of support. Additionally, **nearly 60% of children in need (approx. 12,000 children)** benefited from focused psychosocial support activities.



With rising sexual and gender-based violence (SGBV), sensitization and access to essential services are more needed than ever, but COVID-19 movement restrictions is reducing access to safe spaces. **Partners still reached over 45,000 individuals with essential SGBV services and nearly 80,000 individuals through community-level SGBV awareness-raising and sensitization.**



Despite COVID-19 movement restrictions, **nearly 15,000 people (41% of the target) received tailored counseling** on housing, land and property rights and mediation support with landlords. **Over 13,000 severely socio-economically vulnerable individuals were provided with cash-for-rent assistance.** These interventions were key to mitigate rising eviction risks.



Despite underfunding of shelter activities, **nearly 190,000 displaced Syrians received shelter assistance to maintain their shelters** in informal settlements or non-residential shelters at a safe and livable standard. **Nearly 9,200 displaced Syrians were supported to upgrade their shelters** in residential buildings to improve their living conditions and enhance their safety, security and privacy, including security of tenure.




With rising vulnerabilities, competition for jobs and access to services are increasingly cited as a source of tensions. As a mitigation measure, **more than 65 municipalities were supported to strengthen basic service provision** and reduce resource pressure in high-risk communities. It is estimated that these projects **benefited over 250,000 people**.




New dialogue initiatives to support social stability **reached nearly 41,000 youth** who are now better able to positively engage with their communities. This is an **increase of over 200%** from 2019.
